## PRESIDENTS' LETTER by Shirley Breeze

Sometimes we forget just how multi-faceted AAUW is. In its resolve to advocate for women, it is active on a great number of fronts.

At the classroom level, it is active in STEM and Title IX. Two of its most popular STEM programs are Tech Trek and Tech Savvy; both of these are aimed at introducing STEM to middle school girls. Title IX applies to any school district that receives federal funds; AAUW has been instrumental in the distribution of Title IX materials to school districts throughout the country and in some area has monitored school districts for compliance.

On college campuses, AAUW has several initiatives. These include NCCWSL, Elect Her, Start Smart, and reducing and eradicating compus sexual assault. NCCWSL is the leadership program each spring for women college students. It promotes opportunities for young women to grow in leadership

Most people are aware of AAUW's extensive grant program. This year it will distribute almost \$4 million to women and men to pursue a variety of educational and community opportunities.

Work Smart is designed to improve women's pursuit of an equitable salary in the work place. Training sessions are held in businesses throughout the country. One of AAUW's major emphases is pay

equity legislation. For states working on pay equity issues, including Missouri, AAUW provides extensive support materials.

Recently, AAUW started providing to states a program called State Net; this initiative tracks state legislation and provides a report every week or so on what is happening in your state. State policy leaders can then move rapidly to respond to any legislation.

One of the most well-known programs is LAF--Legal Advocacy Fund. AAUW provides monetary support for women and men who are suing over discrimination cases in educational institutions and workplaces.

At the national level, in addition to providing extensive legislative support through its Public Policy office, it activates a lobby corps each session which works the Hill every week to support national legislation advocating for women and to disprove that which does not support women or which might be harmful to women.

Several international programs are in place also. AAUW has Observer Status at the United Nations and has had for several decades. This status gives AAUW access to people working for women throughout the world. Human Trafficking is another one of AAUW's initiatives. This problem is worldwide in nature; our work in this area provides assistance to women who are trafficked around the globe.

These initiatives are just a few of the many areas AAUW advocates for women and girls.

#### BYLAWS PROPOSAL ACCEPTED BY NATIONAL

The branch Diversity Committee has written and submitted a proposed bylaw amendment. The proposed amendment has been accepted for consideration and voting at the time of the convention. Our proposal and any others can be voted on by any member, whether or not she or he is present at the convention.

The required format is somewhat complex and legalistic. The core of the amendment is to allow interested people without degrees to join AAUW as *advocates* who would have most but not all the rights as degreed members.

This is the key part of the amendment:

## Article IV Section 2

- C. Advocate
- (1) Eligibility. An individual who supports the mission of AAUW but does not meet the eligibility requirements for an individual member shall be eligible to receive admission to AAUW membership as an advocate; such membership shall be granted upon payment of AUW dues.
- (2)Rights and Responsibilities. An advocate has all of the rights and responsibilities of an individual member except an advocate shall not be entitled to vote on any item of AAUW business, serve as an officer or director of AAUW, serve on an AAUW committee or serve as the designated contact for administration or finance of an AAUW affiliate.\*
- \*(2) Refers to National AAUW. "Designated contact for administration or finance of an AAUW affiliate" means the president or treasurer of a branch. Individual branches can determine other rights and responsibilities of advocates within the branch, for instance, serving on branch committees, serving as branch officers not named above, voting on branch issues.
