# REPORT ON APRIL BRANCH MEETING

The program for the April meeting was arranged by Kathy McKemy and was presented by Jennifer Cordia RN, BSN, MBA, who is Vice President of Patient Care and Chief Nursing Officer at Christian Hospital. She spoke about the new Community Health Access Program (CHAP) which recently became operational at Christian Hospital and its satellite Northwest Healthcare. The purpose of CHAP is to improve patient care and reduce "medically unnecessary" use of emergency rooms. It involves using Advanced Practice paramedics and an ED triage nurse, Community Health Resource Centers at both facilities--by referral by paramedics and triage nurses-- and Partnerships with community leaders and organizations. Thank you to Kathy for arranging this excellent program.

# CAROLYN'S CORNER

**EQUAL RIGHTS ACTION DAY,** April 8<sup>th</sup> in Jefferson City, was an awesome day! Lillian Boly and I rode down on NARAL chartered bus, to join women from NOW, LEAGUE OF WOMEN VOTERS, MISSOURI WOMEN'S NETWORK, COALITION OF LABOR WOMEN, MISSOURI WOMEN UNITED and other organizations in a state-wide rally for equality for women. We joined together in a crowd of women and supportive men, four blocks long, in a march to the Capitol where we converged inside the capitol to rally for Equity. In this assembly we heard words of hope from dedicated women leaders, including Shirley Breeze (representing Missouri Women's Network), and Karen Francis (AAUW), moderator.

AAUW state president Linda Berube stated that we much break through the economic barrier for women and girls through advocacy, education, philanthropy and research. She stated that "Equity means even, just and equal." State representative Karla May said that "People who do not believe in equal pay for equal work should not be elected." Representative Charles Norton stressed that "No member of the Missouri government has the right to take care of your health. Women's rights should reign supreme!"

We were also reminded of some alarming statistics: Women make 76-77% of the amount earned by men in the same positions; African American and Latino women make even less than that. A speaker for NARAL stated that 41 of 63 state representatives are pro-choice and that there are only 7 women of 37 state senators. A spokeswomen for labor women said that women in unions make about 13% less than non-union male counterparts. We also heard the statistic that 40% of women are the primary family wage earners and that 32% of those earn only minimum wage.

Equality in many areas is a battle we must continue to fight and it will take woman-power to achieve it. To quote one of the speakers: "Women need to help other women." We have a big job ahead of us and we need to continue to rally for equality for everyone and for passage of the Equal Rights Amendment in Missouri. If we (women) speak up, educate, elect and support our cause, we can win.

# PUBLIC POLICY by Martha Panetti with Lovene Hartman

Our Ferguson-Florissant AAUW branch was well represented at the Equal Pay Rally in Jefferson City on Tuesday, April 8.

Two of our members were among the presenters. Karen Francis spoke, representing AAUW, and introduced the various speakers. Shirley Breeze, representing the Missouri Women's Network as well as the AAUW Leadership Corps, also spoke, pointing out that the Missouri Senate currently includes over 30 men and only 7 women. Shirley's vision it to add one more woman senator each year.

Our branch President, Carolyn Herkstroeter, and our branch Treasurer, Lillian Boly, also traveled to Jeff City

for the event. (See Carolyn's report.)

Of course, there were a number of women's organizations participating in the event. Elaine Blodgett, representing the League of Women Voters, spoke in opposition to proposed photo ID laws, explaining that such a law is not needed, since there has not been a significant amount of voter fraud in Missouri. The Women's Labor Coalition representative spoke in opposition to proposed "Right to Work" laws, explaining that such laws in other states have resulted in lower safety standards as well as lower pay.

Later in the week, public policy co-chairs Lovene Hartman and Martha Panetti conferred as they reviewed information about the many AAUW-related public policy issues currently on the agenda at both the state and the national level.

As you know, AAUW's mission is "advancing equity for women and girls through advocacy, education, philanthropy, and research." AAUW believes that "true equity requires a balance between the rights of the individual and the needs of the community," and thus "opposes all forms of discrimination and supports constitutional protection for the civil rights of all individuals."

Of course, many of you have joined in the current effort to persuade the Missouri Legislature to ratify the Equal Rights Amendment. Keep sending those emails and making those phone calls!

No doubt you have heard/read comments by some who insist women already receive equal pay for equal work. But AAUW's most recent research on the subject, discussed in its publication, *Graduating to a Pay Gap*, shows that just one year after graduating from college, women are earning significantly less than men with the same degree working in the same industry. The gap increases over time, and affects women throughout their lives, since lower pay results in lower social security and retirement benefits when they retire.

Of course, you know that President Obama has signed an executive order which bans federal contractors from retaliating against employees who discuss salary among their colleagues. Lilly Ledbetter, who many of you met at the Equality brunch here a few years ago, was part of the Equality Day activities in Washington, D.C. Unfortunately, the U.S. Senate declined to act on the Paycheck Fairness Act, which is also supported by the President.

AAUW encourages you to contact your U.S. Senators to let them know of your support for the Paycheck Fairness Act, thanking those senators who voted for it and expressing your disappointment in the actions of those who voted against it.

Hundreds of thousands of Missouri residents do not have access to affordable health care, largely because of the failure of the Missouri state legislature to enact legislation that would expand Medicaid. AAUW is among the women's organizations urging you to continue to urge your state reps and senators to act to expand Medicaid. The current situation is wrong from both a moral and an economic standpoint. Simple justice principles support the idea that everyone should be able to obtain health insurance that covers them And from an economic standpoint, we need to remember that by failing to expand Medicaid and thus receive significant federal tax dollars, we are instead sending incredible amounts of our federal tax dollars to help fund Medicaid programs in other states. Meanwhile, since hospitals are required to provide treatment to patients who show up in emergency rooms, we continue to pay higher premiums to cover some of the cost of uninsured patients.

Of course, these are just some of the issues needing attention. As we end our program year, we encourage you to keep following AAUW news and contact your elected representatives at both state and federal levels.

We hope many of you will attend the Equality Day Brunch in August . . . . and you will hear more from us in the September issue of our newsletter.

## AAUW CELEBRATES 125 YEARS OF FELLOWSHIPS AND GRANTS

In 1971 the AAUW Educational Foundation created the Research and Projects Grant program by voting to set aside \$5,000 in grants for several AAUW states in support of public service projects. Fifty

members from 36 states received the first grants in 1972 on a range of topics including women's struggles to balance home and work life, the establishment of women's resource centers on college campuses, and the emergence of women's political involvement in the antinuclear movement.
