#### **PRESIDENTS' LETTER by Pat Kelemen**

Many community and church groups increase their efforts to ensure that even the poorest people, especially the children, have what they need and some of what they want. I'm sure that many branch members always join in those efforts.

Celebrations are part of the season. Church services, decorations galore, and family gatherings brighten the days. In our branch, the holiday event will be a chance for us to gather to enjoy each other's company, good food, and beautiful entertainment. Book group is also planning a holiday gathering.

Life being what it is, the fun and joy of the season are tempered by certain realities. We mourn the passing of 49-year member Elaine Simpson. We are also fully aware that hard work remains for the whole North County community in the aftermath of last year's events in Ferguson. Several members have been involved in this work and continue to be. International events raise our levels of anxiety.

The challenge for all of us it to maintain a balance that allows us to fully enjoy the beauty of the holidays.



#### **PUBLIC POLICY by Shirley Breeze**

The Missouri Legislature goes back into session on January 6, 2016. What can the citizens of Missouri expect from this session? All reports indicate that many of the same issues and legislation that were filed and debated last session will reappear in 2016. Bill filing starts for the upcoming session on December 1, 2015.

## Minimum Wage

The current minimum wage in Missouri is \$7.65. Six out of 10 minimum wage workers are women. Two of the prominent low wage jobs are child care workers and home health aides, both 90 percent female. Their average wages are far below the \$15 per hour usually called for in minimum wage legislation across the US. Other low-wage earners are found in fast food jobs, as cashiers and in retail stores, all of which are predominately women.

## Syrian Refugees

Governor Nixon has not made a definite statement whether Missouri would be willing to accept these refugees. A major portion of the people affected are women and children.

#### Payday Loans

The average annual interest rate on payday loans in Missouri currently is 444 percent. Many poor families, many headed by women, depend upon payday loans to get them from one pay check to the next.

#### Medicaid Expansion

Missouri's legislature continues to refuse to expand Medicaid. The 10-year total cost in Missouri would be \$1,573 million. The federal funding lost by not expanding Medicaid amounts to \$17.8 billion; the hospital reimbursement loss is \$8.8 billion. Two-thirds of those who rely on Medicaid for their healthcare are women and their children.

### Ethics

A recent national report on state ethics gave Missouri a D-. Currently, there is not cap on donations to sitting legislators; also, they can accept any and all lobbyist gifts, including dinners, sports tickets, etc. Legislators can become lobbyists immediately upon the end of their terms of office. Most other states restrict this practice. The recent high level cases in Missouri's legislature affecting young women illustrates the need to address ethics in Jefferson City.

#### Right to Work

This issue was hotly debated last session. Governor Nixon vetoed it. His veto was sustained. Union members who are women make a considerably higher wage than whose who are not union. A recent report found that women represented by a union earn an average of \$212 more per week than women in nonunion jobs.

#### APPRECIATING DIVERSE HOLIDAY TRADITIONS by Martha Panetti

What are your Holiday traditions: Do you celebrate the exact same ways as your neighbors? Or your in-laws?

I was well into adulthood before I learned that on Thanksgiving, not everyone "carves the turkey" at the dining room table ala my relatives or the family on the Cosby show. Even more surprising, some folks don't choose turkey as the main entrée.

Christmas, of course, includes many traditions. A friend from Austria, and another originally from Germany, both told me that in their native countries the Christmas tree was never trimmed until Christmas Eve, and that real candles were used to trim the real tree. In Austria, Kris Kind (the spirit of the child angel, Jesus) brings gifts for children rather that the U.S. Santa Claus.

While Christmas, by definition, is considered a Christian holiday, many people who are not Christian celebrate Christmas. A friend who grew up in Korea told me that Christmas is a national holiday in Korea, despite the fact that there are more Buddhists than Christians in Korea. Buddhists observe April 8 as their major religious observance.

While people of the Jewish faith observe several high holy days, many Jewish people also observe the secular traditions associated with Christmas.

Many African Americans observe Kwanzaa from December 26 to January 1. It celebrates the seven principles of African heritage.

Muslims, of course, observe Ramadan.

So as we consider aspects of diversity in our communities, we might want to recognize and respect the diverse traditions our neighbors celebrate.

## TRIBUTE TO ELAINE SIMPSON

Longtime branch member Elaine Simpson died Friday, November 13 after a courageous battle with cancer and other serious health problems. A memorial service was held on November 20 at the First Baptist Church of Ferguson. Twelve branch members and many church members and friends attended. Burial was in Springfield, Missouri.

Elaine was born in Springfield, Missouri. She received her Bachelor's from Missouri State University and her Master's from Indiana University. She taught in the business department at Southwest Baptist University, Bolivar, from 1957-63 and then taught accounting at St. Louis Community College at Florissant Valley 1964-94.

Elaine was an accomplished organist and served as interim or substitute organist in many churches. In retirement, she was an avid volunteer for Friendship International, ESL classes, St. Louis Symphony, St. Louis Chamber of Commerce Visitors Bureau, The Touhill at UMSL, and at her church,

Elaine joined AAUW on July 1, 1966. She was always a very active member. She served as Treasurer for eleven 2-year terms, Secretary for three 2-year terns, Educational Foundation chair for nine terms, Finance chair for three terms, AAUW Funds chair for 2 terms, and Public Policy Chair for one term. Elaine could always be counted on for branch projects. She was a named gift honoree in 2010. She also enjoyed "fun raiser" outings and book group.
