PUBLIC POLICY by Judy Holmes

Probably all of us have someone in our circle of family, friends or acquaintances who has or has had student loan. Perhaps you have a student loan or had one! All of us have heard or experienced stories about student loans, some not as happy as others.

National AAUW has published a booklet titled DEEPER IN DEBT about women and student loans. They label it n executive summary and recommendations. In this small booklet, AAUW has gathered many pertinent facts and have several public policy recommendations we can and should act upon. The booklet does touch upon the necessity of institutions to prepare students for successful careers by way of counseling.

In this article, I would like to ask you to think about how necessary preparation for seeking and using a student loan is. It is probably preferable to use the largesse of parents, scholarships, grants, employment, any other means of getting an education before seeking a loan.

I am sure you have heard of the word discernment, often in relation to someone who is considering a religious calling. The dictionary says it means insight. I think a period of discernment, or soul-searching, to gain insight would be wise before taking on a loan. We can all use some insight.

It would be a time to communicate with counselors, parents, mentors, fellow students--all sources. It is time to communicate with ones self. Be sure you know what you are getting into.

Most people go to college to prepare for a profession, career, or way to support oneself. Young person often has a difficult time knowing what to plan for the future. Questions that come to mind are many. Do I have the skills or propensity for what I would like to do? Would that profession pay enough to support myself and pay back the loan? How easy is it to get a joy in the profession I chose? Would I mind putting off marriage until I can get the loan repaid? Would it be wise not to have children until the loan is repaid?

Sometimes a year of working before going to college is helpful. Perhaps the military is a way to education or job training. Sometimes there are internships or volunteer work that help one to make decisions about the future. Perhaps you have decided on a goal you want no matter what and just really want to go for it!

I am sure high school and college counselors do try to furnish necessary information and give all guidance they have available. There are often many relatives and friends who are interested in advising.

AAUW FUNDRAISING

The major fundraising activity by AAUW's National organization centers around AAUW Fund; Legal Advocacy Fund is also a primary focus of funding. AAUW Fund is primarily used for operations at the National level; i.e., printing, travel, salaries. These are activities that keep the organization moving and keep it vibrant and relevant.

The fundraising activities are on a calendar year basis; therefore, on December 31 of each year, each branch's contributions are calculated. Branch donations to National are important in two vital ways; for the STAR Award recognition and for the Named Gift Recipient designation. The STAR Award is a yearly recognition by the state AAUW. One of the determining categories is the branch's financial contributions. Another important recognition is the ability to honor a branch member by having her be a Named Gift Recipient; this year's award went to Pam Meyers. Each branch is allowed one recipient for each \$500.00 of financial contributions to National.
