PUBLIC POLICY by Dr. Tommie Turner The Importance of STEM Education

Science, technology, engineering and math (STEM) careers are both innovative and lucrative opportunities for women, minorities, and other underrepresented communities. According to the United States Department of Labor/Bureau of Labor and Statistics, "Employment of life, physical, and social science occupations is projected to grow 10 percent from 2016 to 2026, faster than the average for all occupations, which will result in about 124,800 new jobs. Increasing demand for expertise in the sciences, particularly in occupations involved in biomedical research, psychology, energy management and environmental protection, is projected to result in employment growth. The median annual wage for life, physical, and social science occupations was \$64,510 in My 2017, which was higher than the median wage for all occupations of \$37,690.

Addressing global challenges (food security, water quality, national security, energy efficiency, etc.) requires the intellect and skills of a prepared workforce. In order for the United States to continue to compete with other developed countries in the advancement of STEM discoveries, there is room at the workforce table for everyone, especially women, minorities and other underrepresented communities. From a national point of view, according to a 2017 report from the U.S. Department of Commerce Economics and Statistics Administration Office of the Chief Economist, women filled 37 percent of all U.S. jobs in 2015 but held only 24 percent of STEM jobs. Likewise, women constitute slightly more than half of college educated workers but make up only 25 percent of college educated STEM workers. Women with STEM jobs earned 35 percent more than comparable women in non-STEM jobs--even higher than the 30 percent STEM premium for men. As result, the gender wage gap is smaller in STEM jobs than in non-STEM jobs. Women with STEM jobs also earned 40 percent more than men with non-STEM jobs.

To bring the issue closer to home that women, minorities and other underrepresented communities have career opportunities to work in STEM jobs, the 2014 State of the St. Louis STEM Workforce Report states that "The St. Louis workforce region has seen a large demand for STEM workers with few jobseekers chasing those opportunities. In 2013 there were over 23,000 STEM job ads in the region yet just over 2,000 jobseekers were looking for employment in those occupations. From 2012 to 2022 STEM jobs in St. Louis are also expected to grow by 12.4% over the 10-year period, compared to 9.2% for non-STEM jobs. STEM fields also pay considerably higher wages, helping both the worker and regional economy. With an average earnings of \$79,290, STEM workers re paid nearly 80% more than Non-STEM job holders (44,294).

Promoting STEM professional careers to women, minorities and underrepresented communities will not only economically advance individual households, but also the metro St. Louis region and the state of Missouri.
